

**THE XTREME® SUMMER 2022 SWEEPSTAKES  
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION PERIOD:** “The Xtreme® Summer 2022 Sweepstakes” (“Sweepstakes”) begins at 10:00 A.M. Central Time (“CT”) on 8/1/22 & ends at 11:59 P.M. CT on 8/31/22 (“Promotion Period”).

2. **ELIGIBILITY:** Sweepstakes open only to legal United States residents who reside in Arizona, California, Colorado, Georgia, Illinois, Maine, Nevada, New Jersey, North Carolina, South Carolina and Texas and are eighteen (18) years of age or older at time of Entry. - **ENTER ONLINE:** During the Promotion Period, visit [www.xtreme2022.com](http://www.xtreme2022.com) (“Website”) & follow instructions to complete & submit the online Entry form (“Online Entry” or “Entry”), to enter the Sweepstakes. Online Entries must be received by 11:59 P.M. CT on 8/31/22. Limit one Online Entry per person/email address per day.

Administrator, an independent judging organization whose decisions are final on all matters relating to Sweepstakes. Odds of winning depend on number of eligible Entries received.

5. **WINNER NOTIFICATION:** Potential winners will be notified by phone/email. Potential winners will then be required to execute & return, via email/mail, an Affidavit of Eligibility & Liability/Publicity Release (where legal) within three (3) days of notification attempt. Noncompliance within this time frame, return of prize or prize notification as undeliverable or declining prize for any reason, will result in disqualification & selection of an alternative winner through a random drawing.
